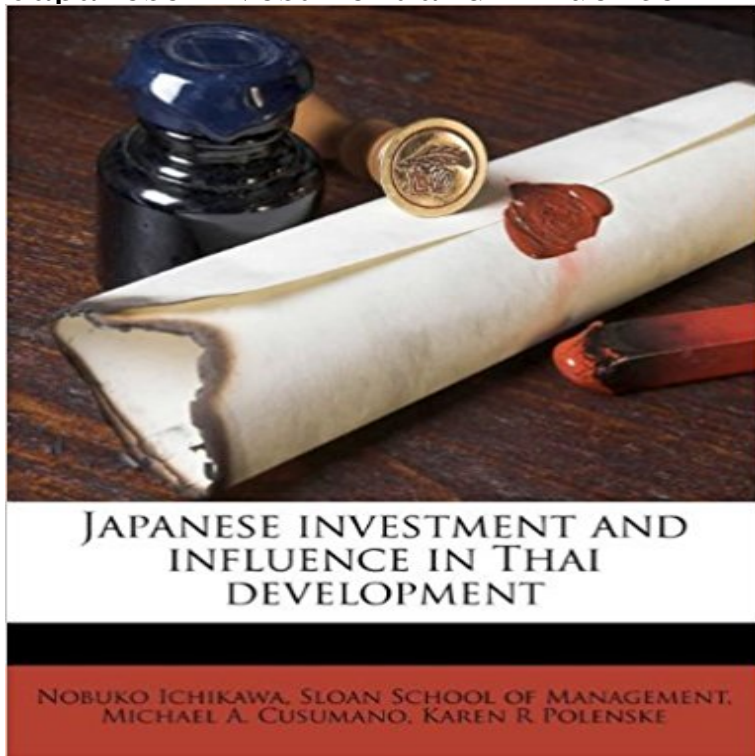


Japanese investment and influence in Thai development
