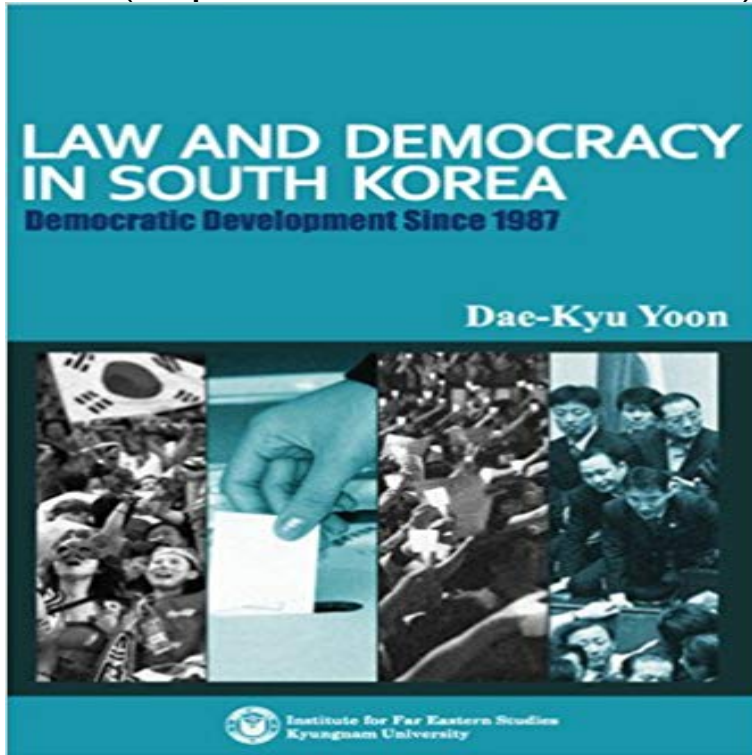


Law and Democracy in South Korea: Democratic Development Since 1987 (Explorations in Korean Studies)
