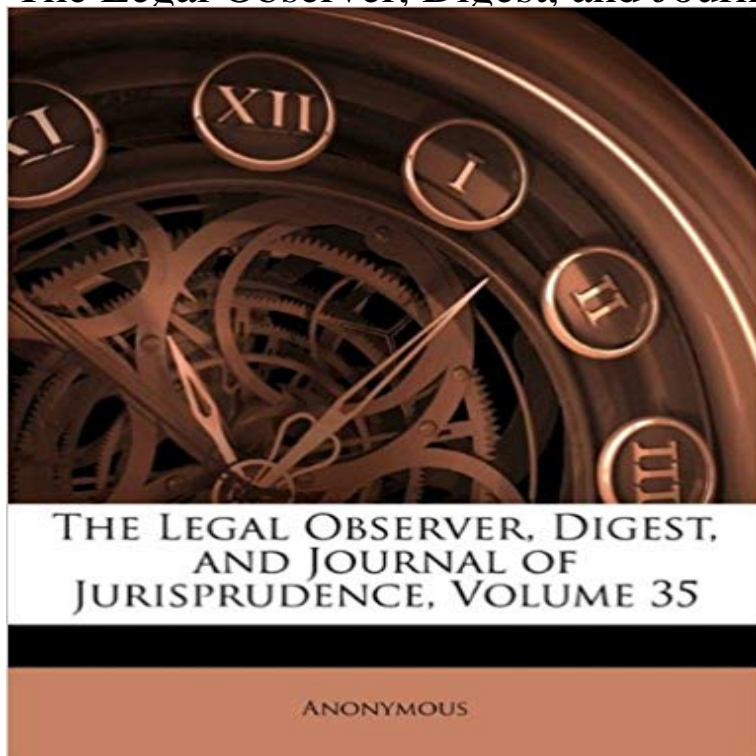


The Legal Observer, Digest, and Journal of Jurisprudence, Volume 35
