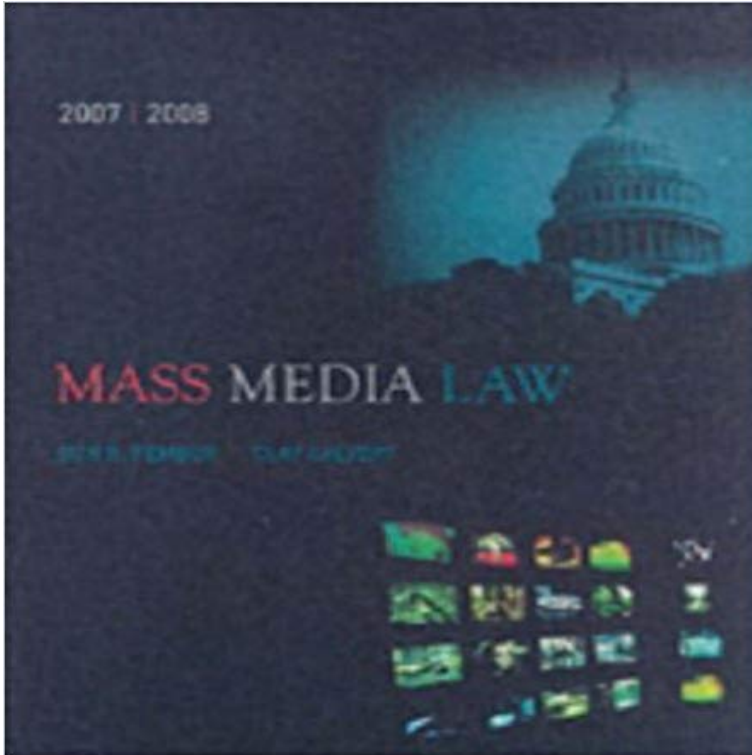


Mass Media Law 2007-2008
