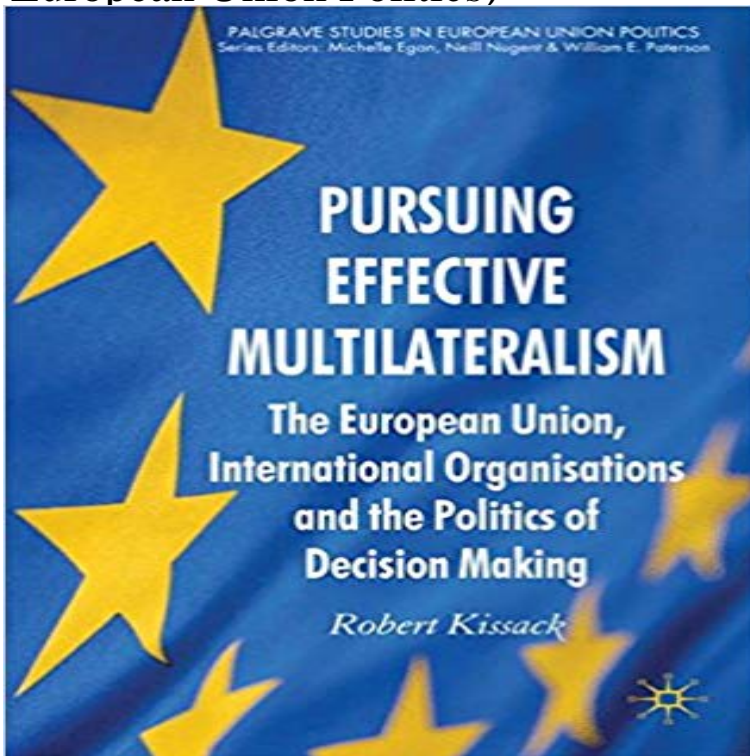


Pursuing Effective Multilateralism: The European Union, International Organisations and the Politics of Decision Making (Palgrave Studies in European Union Politics)
