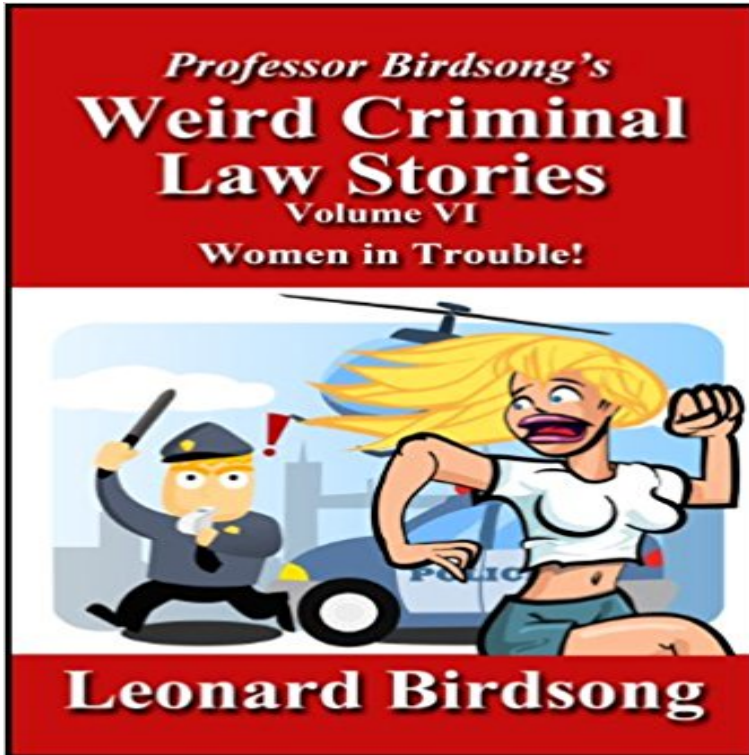


Professor Birdsong's Weird Criminal Law Stories - Volume 6: Women in Trouble
