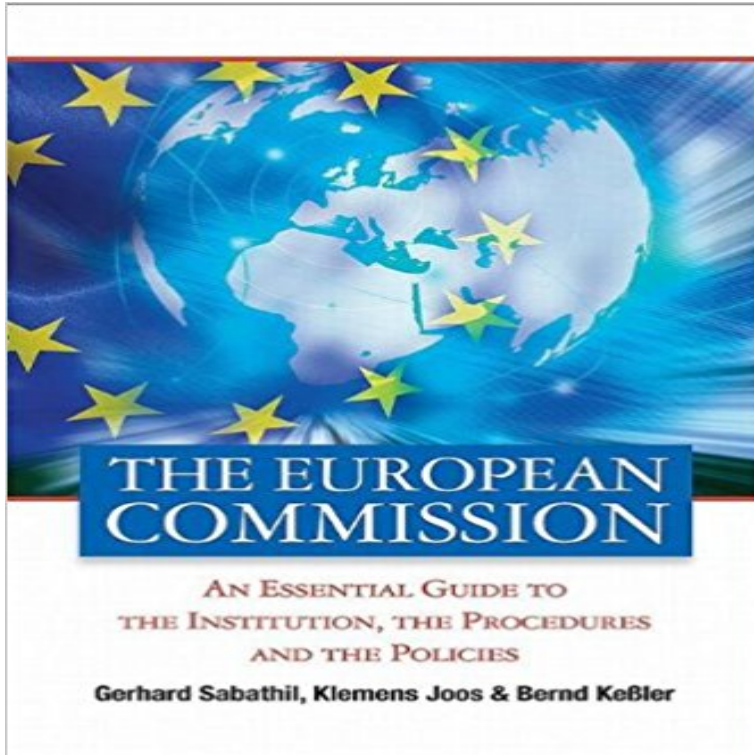


# The European Commission: An Essential Guide to the Institution, the Procedures and the Policies
